Meeting called to order and minutes from April 20, 2021 read and accepted.

PRESIDENT:

- Gorby stated that the basket drawing made \$67.24.
- A vote was taken from the Guild members and the vote was unanimous that we stay at Knob Prairie.
 - Suggestion was made that more people car pool.
 - Knob Prairie has 42 parking spaces; Fairborn Sr. Center has 59 (counted by Nancy W.)

LIBRARY:

- An idea was made to sell books at the Quilt Show.

QUILTS OF VALOR:

- Debbie reported that 7 people were at the sew-in at the Little Shop of Stitches on July 29.
- On August 6, 2021 there will be a presentation of 24 quilts in St. Louis, Missouri presented by the Missouri Coordinator. In addition to the 24 quilts that members made for the St. Louis presentation, Carol Mathews individually made 11 quilts for a presentation at her church (Knob Prairie).
- Debbie stated that there will be an estate sale, hosted by the daughter of Norma Swanson, at 2801 Bellsburg Drive, Dayton on Sunday, August 1, 2021. When asked by daughter, Board suggested to charge \$3 per yard or \$5 for 2 yards for material.

TREASURER:

- Kim reported that \$1,900 was turned in from the basket drawing and workshops.
- President Gorby and Vice President Mary Lou M. and Treasurer Kim G. will be added as signers on main bank account. A copy of the minutes will be to be added to the signature card.
- Mary Lou needs a debit card for Programs. Kim asked that receipts be sent to her when card is used.

RAFFLE QUILT:

- The squares will be colored with Prisma Colors. Colors to be used will be chosen by Kim.
- There will be workshops held where the squares are to be colored.
- The quilt will be constructed using Quilt as You Go with sashing in between.

MEMBERSHIP:

- Tere stated that 183 members are listed on the spread sheet.
- 71 signed in at the June meeting; one new person.

• Mail box is currently in Beavercreek. Keys are held by Gorby and Tere. As of the meeting Nancy W. (who lives in Beavercreek) will get a key from Gorby and will pick up the mail.

VICE PRESIDENT:

- 2022 suggestion: Vice President takes workshops without paying. The V.P. is not to put her name on the list, which will open spot for another.
- Kim will not be at the September meeting. She will give checkbook to Mary Lou.
